1. Introduction

The Public Utility Company **Belgrade Metro and Train** (hereinafter: BMV) is a socially responsible and reliable company operating in accordance with laws, best practices, and principles of environmental and employee protection.

BMT is managing the development of the Belgrade Metro on behalf of the City of Belgrade. It is currently working on the detailed design of the **First Line, Phase 1**.

The Project is being implemented in compliance with national regulations and international standards, including the **IFC Environmental and Social Standards**.

BMV places a high priority on cooperation with stakeholders. The **Stakeholder Engagement Plan**, prepared in **July 2024**, defines the methods of communication and cooperation.

This document monitors the engagement of key stakeholders from **December 2022 to December 2024**, with the aim of identifying and addressing environmental and social issues related to the Project.
